

Coastal Off-Road Release And Hold Harmless Agreement

This release and indemnification is begins on this _____ day of _____, 20____, by _____ (hereinafter referred to as Participant”), to Coastal Off Road Expeditions (referred to herein as “CORE”), concerning Participant’s involvement in the following CORE’s activities, events, educational programs, trips, or other events (hereinafter referred to as the “Events”) that is sponsored by CORE or related to the Participant’s membership with CORE. This agreement does not expire, however it may be modified in the future, requiring the Participant to complete the agreement again.

RELEASE AND INDEMNIFICATION:

I acknowledge that my participation off-road riding and included Events and Activities entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the Event or Activity. The risks include, among other things: slips and falls; the possibility of rough terrain; colliding with objects or other people; drivers may be jolted, jarred, bounced, thrown about and otherwise shaken during rides; it is possible that riders could be injured if they come into contact with other passengers, equipment, or other objects; injuries can be sustained from the trail, equipment or from items on the trail such as holes, bumps, ruts, obstacles, tree limbs and branches or rocks; strains, sprains, broken bones and musculoskeletal injuries including head, neck, and back injuries; cuts, abrasions, and bruises; transmissible pathogens or diseases; cardiac related illness; equipment failure; condition of the track/trail; exhaustion; exposure to the elements of the outdoors and natural surroundings which could cause hypothermia, hyperthermia (heat related illnesses), heat exhaustion, sunburn, dehydration; exposure to potentially dangerous wild animals, insect bites, and hazardous plant life; further, passengers can be thrown from their vehicle or machine which can result in any of the above events occurring; collisions, and flipping over; the negligence of participants, or other persons who may be present; accidents or illness can occur in remote places without medical facilities; my own physical condition, and the physical exertion associated with this activity.

Participant, in the Participant’s individual capacity, and for Participant’s heirs, executors and assigns, releases CORE from any and all liability for personal injury or property damage which may be suffered by the Participant arising out of or in connection with the participation of the Participant in the above-described Events as well as all activities held by, endorsed by, advertised by, or participated in by CORE, or singularly by a CORE participant, and Participant agrees to hold CORE free, clear, and harmless from any and all claims and demands for personal injury or property damage arising out of Participant’s participation in said Events or Activities. Participant releases CORE from and agrees to indemnify and hold CORE harmless against any claims, demands, damages, costs, and expenses, including reasonable attorney's fees for defending the claims and demands, for injury or damage to the person or property of Participant or any other party arising out of Participant’s participation in the Event or Activity, INCLUDING CLAIMS OR DEMANDS BASED ON THE NEGLIGENCE OF CORE, as well as claims based on the conduct of CORE, CORE’s board of directors, volunteers, agents, employees, vendors, or administrative staff.
